GREF 2005

The annual meeting of GREF was held at the Méridien Hotel in Brussels, Belgium, from 11 to 15 May. The meeting was attended by 80 participants from 23 European countries.

The major items on the agenda were gambling addiction and European Union developments regarding gambling. It was decided to establish a fourth Working Group on Illegal Gambling, to monitor developments and to exchange information related to illegal gambling. The biannual election of the GREF Executive Board also took place this year. The Forum elected Tom Kavanagh (Gaming Board for Great Britain, United Kingdom) as the new Chairman of GREF.
